SUBJECT: General School Aid Eligibility and Choice and Charter Reductions

At your request, I am providing information on general school aid eligibility for school districts and the reductions made to aid eligibility related to choice and charter programs.

Background

The general school aids appropriation funds equalization, integration, and special adjustment aid. (High poverty aid, which is also a form of general aid, is funded from a separate appropriation.) Almost all of the funding in the appropriation is distributed through the equalization aid formula. Payments to school districts from the general aid appropriation are also affected by the statutory funding provisions for other K-12 programs, such as the private school choice programs, the independent charter school program, and the special needs scholarship program. While the specific details of the funding for these programs differ to some degree, there are two general methods by which they are funded.

One method is used to fund the Milwaukee private school choice program and the independent charter school program as it relates to entities that were allowed to authorize schools prior to 2015 Act 55. Under this method, the district of residence does not count pupils participating in the program for revenue limit and general aid purposes. The general aid payment for either the district of residence (Milwaukee private school choice program) or for all districts statewide (independent charter school program for pre-2015 authorizers) is reduced by a specified amount related to the cost of payments under the program. Statutes do not specify any unique treatment of these aid reductions for other purposes. As a result, districts are able to levy to make up for, or backfill, these aid reductions under revenue limits.

The other method is used to fund the Racine and statewide private school choice programs for incoming pupils, the special needs scholarship program, and the independent charter school program as it relates to entities that were allowed to authorize schools under 2015 Act 55 or 2017

Act 59. Under this method, the district of residence for pupils participating in the program is able to count those pupils for revenue limit purposes (independent charter school program for post-2015 authorizers) or receive a nonrecurring revenue limit adjustment for those pupils (incoming pupils under the Racine and statewide school choice programs and all pupils in the special needs scholarship program). The district of residence counts these pupils for general aid purposes. The general aid payment for the district of residence is reduced by a specified amount related to the cost of payments under the program. Statutes specify that these aid reductions do not affect the amount determined to be received by the district as general aid for any other purpose. As a result, the district is not able to levy property taxes to backfill these aid reductions under revenue limits.

2018-19 Aid Reductions

DPI pays the operators of independent charter schools a statutorily-determined per pupil amount each year (\$8,619 in 2018-19). By law, the cost of payments for pupils attending schools chartered by pre-2015 authorizers (the City of Milwaukee, UW-Milwaukee, and UW-Parkside) is offset by a proportional reduction in the general aid for which each district is eligible by an amount totaling the estimated payments for these pupils. Based on the October 15, 2018, general school aids estimate, in 2018-19, general aid statewide will be reduced by a total of \$71.5 million for these charters. Each district's general aid will be reduced proportionately by 1.5% to generate the total statewide amount of \$71.5 million. Under revenue limits, school districts may levy property taxes to make up for the amount of revenue lost due to these aid reductions.

A pupil attending a school chartered by a post-2015 authorizer (the Office of Educational Opportunity in the UW System) is counted by their district of residence for revenue limit and general aid purposes. DPI is required to reduce a district's general aid payment in an amount equal to the total of the payments made for pupils attending these schools and residing in the district. A district may not levy to backfill that aid reduction. In 2018-19, the aid reductions for these charters total an estimated \$2.2 million.

Under the private school choice programs, the state pays a statutorily-determined per pupil amount for children from eligible families to attend participating private schools. The payment for 2018-19 is \$7,754 for a pupil in grades K-8 and \$8,400 for a pupil in grades 9-12.

For the Milwaukee program, DPI is required by law to reduce the general aid for which MPS is eligible in 2018-19 by a net amount of 19.2% of the estimated total cost of the Milwaukee program, after consideration of aid that is paid to the City of Milwaukee to reduce the levy it raises on behalf of MPS. (Under the provisions of 2013 Act 20, this percentage will be reduced by 3.2 percentage points each year, until no aid reduction is made beginning in 2024-25.) The October 15, 2018, general aid calculation uses an estimate of \$221.8 million for the total cost of the Milwaukee program in 2018-19. Thus, MPS's general aid will be reduced by a total of \$42.6 million. Under revenue limits, MPS can levy to make up for the aid reduction, less any high poverty aid received by MPS.

For the Racine and statewide private school choice programs, payments for continuing pupils (those pupils who first participated in the programs in the 2014-15 school year or prior) are fully funded from the state general fund. The cost of payments for incoming pupils (pupils who first

participated in the 2015-16 school year or later) is offset by a reduction in the state aid that would otherwise be paid to the school district of residence of participating pupils. School districts count incoming choice pupils for general aids on a prior year basis, and receive a revenue limit adjustment for each pupil in the current year. The revenue limit adjustment is equal to the amount of the aid reduction. Other than the revenue limit adjustment, districts cannot levy to make up for these aid reductions. In 2018-19, the state aid reduction for incoming pupils totaled approximately \$68.3 million (\$18.3 million for the Racine program and \$50.0 million for the statewide program).

Under the special needs scholarship program, a statutorily-determined per pupil amount (\$12,431 in 2018-19) is paid to private schools on behalf of participating special needs pupils. The cost of payments under the program is offset by a reduction in the state aid that would otherwise be paid to the school district of residence of participating pupils. Districts count pupils in the program for general aids on a prior year basis, and receive a revenue limit adjustment for each pupil in the current year equal to the aid reduction. Other than the revenue limit adjustment, districts cannot levy to make up for these aid reductions. In 2018-19, aid reductions for the special needs scholarship program total an estimated \$8.4 million.

The attachment provides information on the general aid and choice and charter reductions for each district for 2018-19. The first column of numbers in attachment shows the general school aid eligibility for each district under the applicable statutory formulas, prior to any aid reductions. The next two columns show the reductions for the independent charter program for pre-2015 authorizers and the Milwaukee choice program, both of which districts can levy to replace. The fourth column shows the general school aid certification based on the October 15 distribution prepared by DPI, which is the figure that districts use to set their levies under revenue limits. The fifth, sixth, and seventh columns show the reductions for the independent charter program for post-2015 authorizers, the Racine and statewide choice programs, and the special needs scholarship program, which districts cannot replace through the levy. The final column of figures shows each district's general aid net of all of the reductions shown in the attachment. A district with a negative number shown in that column would have its categorical aid, if any, reduced by that amount.
