Commission Referrals to Wisconsin District Attorneys Potential Cross-State Voting (2018 General Election)

At a meeting on February 27, the Wisconsin Elections Commission directed staff to make the following referrals to the appropriate District Attorney for further investigation as to whether an individual voted in the 2018 General Election in both Wisconsin and also another state. The referrals were based on data received from the Electronic Registration Information Center (ERIC) which provides the Commission with potential matches of individuals that may have voted in Wisconsin and another ERIC member state at the same election.

This report is released pursuant to Wis. Stat. § 5.05(5s)(e)2. which states that, “The following records of the commission are open to public inspection and copying under s. 19.35(1): (2) Any record of the action of the commission referring a matter to a district attorney or other prosecutor for investigation or prosecution.”
